Circular Calling Meeting Stated it Was to Protest

Against Allied Movement

Into Russia

39 PLACED IN CUSTODY

While William Revenko, chairman of the Bolshevik meeting called for Prince Arthur Hall yesterday afternoon, was addressing about 700

Russian and Jewish socialists of the

city, an unexpected influx of Dominion police under Captain Carter, registrar of alien enemies, and of city police under Captain Belanger, gave a new excitement to proceedings. Thirty-nine who were participating, who were seated at the front, were taken into custody, removed to the detention quarters for alien enemies, there searched and detained until this morning for further examination. The preliminary search disclosed that some were Austrians, carrying their regular papers. Such of them as are aliens, and not alien enemies may be made the subject of deportation proceedings, and such as are alien enemies will be interned in alien enemy camps for the duration of the war.

tions of the Consolidated Orders

Respecting Censorship issued at Ottawa on May 21, 1918. Under Order 2, which deals with the "prevention of the circulation of objectionable material," paragraph "(a)" construes this to include any adverse or unfavorable statement, report or opinion concerning the causes of the present war or the motives or purposes for which Canada or the United Kingdom of Great Britain and Ireland or any of the Allied nations entered upon or prosecutes the same, which may tend to arouse hostile feeling, create unrest or unsettle or inflame public opinion. The same order is applicable to anything said in connection with the prosecution of the war, or to detract from the united effort of the Dominion in prosecuting it, as well as false statements about any of Canada's public services or the military and naval forces of the British Empire or of the Allies. No person is supposed to have in his or her possession any statement, opinion or report in writing or print containing any objectionable matter. Another clause states: "In any prosecution or proceedings brought or taken under this order . . . all matters alleged in the information, charge or indictment shall be without proof rebuttably presumed to be true." CAUSE OF THE RAID. The document, which caused the descent of Capt. Carter and the Dominion police aided by the city force under Capt. Belanger, was a print-ed circular in Yiddish. stopped, 39 men whose presence at the front showed them to be prominent in the movement were taken into custody, and the crowd moved out of the hall by the police. searched for documents and papers. which might fall under the head of the orders-in-council referred to. Other seizures were male, and translations are being mad'. When the meeting began the chair was taken by Mr. W. Revenko and Mr. B. Richikof. The speakers were to be Messrs. Schneideman and Chwat in Russian; H. Barsky in Yiddish: M. Buhay and J. Shubert in English. It was announced at the beginning in Russian, that a tele-gram had been received from I. Okustzef, New York city, that he could not come owing to a passport not being received. Capt.
