Zirzow had been a lleutenant in the German army, but was now discharged, and there was no obligation upon Zirzow to go back."

Zirzow dined with Nerlich at the Prince George on one occasion, and there showed Nerlich a letter from a sister. The sister regretted that Zirgow was now a prisoner of war, and that he had neglected the opportunity to return home.
