
## Regarding Coming Civic Elections

The Citizens' League believes that at the present time it is the first duty of every Citizen, man or woman, who is entitled to vote in the Civic Elections, to see that his or her name is on the Voters' List in all Wards in which he or she is entitled to vote.

In order to assist all Citizens in this respect, offices have been opened at 185 Lombard Street, opposite the Merchants Bank, where Voters' Lists can be examined and the necessary application forms can be obtained.

## All Applications to be placed on the Voters' List must be made Before October 30th, next

THE policy of the Citizens' League in the Civic Nominations is to neither interfere nor suggest Candidates, but to throw their united strength behind the men chosen by the various Wards who, in their judgment, will serve best all Citizens of Winnipeg.



#### PERSONS ENTITLED TO BE PLACED ON THE VOTERS' LIST—READ CAREFULLY

- All British subjects, male or female, of the full age of twenty-one years and resident or non-resident, who are in their own right on the day of the election:
- (a) Owners of real property rated in the assessment roll for at least \$100.00.
- (b) A lease-holder or tenant of real property, such property valued or rated in the assessment roll for at least \$200.00.
- (c) Where real property is owned jointly by two or more persons, each person is entitled to a vote.
- (d) Where real property is occupied jointly by two or more persons (for example, by a partnership), then each person shall be entitled to a vote.
- (e) Every occupant of a separate portion of a house shall be entitled to a vote. Boarder or lodger, however not entitled to vote.

### HOW TO GET ON VOTERS' LIST IF YOUR NAME IS NOT THERE NOW

By signing the following application and filing it with the Assessment Commissioner at his office, 185 King Street, before October 30th, next.
