Anger a Divine Instinct.

Speaking on the immigration and deportation motion, Canon Scott said in reference to his statement that he would not shake hands again with a German until an amende honorable had been made that anger was a divine instinct. It should not be

used, however, for one's own selfish means. Before he could recognize Germans again they must give some evidence that they were sorry for the things they had done. Comrade Berry, of British Columbia, discussing the Oriental clause, explained that the Chinese and Japanese monopolized the fishing industry and no soldler could get a chance to enter it unless the Federal Government did something.
