BIG ARTILLERY DUELS ON ITALIAN FRONT

AUSTRIANS TRY VAINLY TAKE POSITIONS IN THE LAGARINA

Rome, Feb. 2.—The following official communication was issued

"In the Lagarina Valley morning the ciemy renewed, with the aid of his artiflery, his vain attacks against our positions northeast of Mori, which are still firmly held by

against our positions northeast of Mori, which are still firmly held by our troops.

"There have been encounters by small detachments in the Sugana Valley, in which the enemy was surprised and overcome by the Italians and everywhere repulsed.

"In the Goritz zone and on the Carso front there has been the customary artillery activity. Our guns effectively shelled an enemy column on the march from Marcottini to San Martino. One of our detachments boldly raided an enemy trench routhwest of San Martino. Hifty bombs were thrown, wrecking the trench."

Vienna, Feb. 2.—To-day's official statement says:

"Attacks by an Italian battalion west of Rocegno, in the Sugana Valley, were repulsed. Enemy saps on the Col di Lana slope were taken in hand-to-hand fighting and afterwards blown up. There have been artillery duels on the Isonzo front."

INSANITY THE DEFENCE IN THE CODERRE CASE

FOR DEFENCE COUNSEL ASKS POSTPONEMENT, BUT FOR TRIAL WILL PROCEED.

(Canadian Associated Cable.) Winchester, Feb. 2.—At the Hamp-shire Assizes to-day the counsel decontrol assistes to-day the counsel defending Georges Coderre, the Canadian officer charged with murdering Sergeant Ozanne, applied for the adjournment of the case until the July Assizes on the ground that it was essential to roly upon the defence of insanity. To support this certain witnesses would be required from Canada to speak of the prisoner's and the family's mental condition. These witnesses were expected last Monday, but only Mr. Emil Hioux, legal adviser to Coderre's family, arrived, who personally knew the prisoner. Witnesses in Canada could prove that four cousins were insane and an aunt died in an asylum.

A Colonel of the Canadian Militia had refused to recommend Coderre for a commission owing to his mental condition. After some comment by the Judge, the trial was fixed for Friday. fending Georges Coderre, the Canadian
