LT L. F. JAMIESON WAS ACCIDENTALLY DROWNED

FORMER GRIMSBY PHYSICIAN WAS WITH THE PALESTINE EXPEDITION.

(Special Despatch to The Globe.) Detroit, July 4. --- A cablegram containing news of the death of Lieut L. F. Jamieson, R. A. M. C., son of Rev. Dr. and Mrs. Jamieson of St. Andrew's Presbyterian Church of this city, has just reached the young widow from the War Office, London. The cablegram reads as follows: "Deeply regret Lieut. L. F. Jamieson, R. A. M. C., accidentally drowned June 27. Army Council express sympathy."

No further particulars are given. and this is the only word Mrs. Jamieson has received regarding her husband's death. Lieut, Jamieson left his practice of medicine at Grimsby, Ont., early last fall, went to England, offered his services, was accepted and designated to the Palestine Expedition. For a time he had charge of the Base Hospital at Jerusalem, then was with a Field Ambulance Corps at Jericho, and at the time of his death was attached to a brigade of Field Artillery. He was senior medical officer and had direction of the work. He was the second son of Dr. and Mrs. Jamleson to meet death by drowning, his elder brother having been drowned in the Bad River, Northern Ontarlo, a few, the time of the recent trouble at vears ago.

DEMANDS TO BE SENT **TO INTERNMENT CAMP**

(Special Despatch to The Globe.) Windsor, July 4. - Shouting that he would never pay his fine and demanding that he be sent to an internment camp. Rudolph Schmidt aged 50 years, a German who has been farming in Maidstone township since August, 1914, was to-day ordered by Magistrate Miers to pay a fine of \$125 and costs and to serve a month in jail. The sentence was the maximum provided by law.

Schmidt was arrested by Provincial officers a week ago for having failed to register. When taken into i custody he gave the officers a hard fight before he could be handcuffed. Neighbors say that Schmidt wealthy, and that he is professedly pro-German. A thorough search will he made of his farm premises at once.

TWO YEARS FOR FORGERY.

Austrian Did It to Enable Compatriot to Leave Country.

London, Ont., July 4 .--- For forging the name of Rev. V. Kosoriezoff to enable a fellow-countryman to leave this country, Dionisc Woloshin, an Austrian, was sentenced to two years in Kingston Penitentiary by Magistrate Graydon this morning. He was arrested in Windsor at Ford City.

TO REOPEN "ROSS RIFLE FACTORY"

(Canadian Press Desputch.) Quebec. July 4 .- The factory formerly occupied by the Ross Rifle Company will be reopened in September by the North American Arms Company, Limited, a very large order for the manufacture of revolvers for the United States army having been received by the new company, which has just obtained a charter from the Dominion Government and capitalized at \$2,000,000, the head office to be in Quebec. It is a purely Canadian company, the officers being : Pres., T. A. Russell, Toronto ; Vice-Pres., H. D. Scully, Toronto; and Gen. Manager, Thomas Craig, former General Superin-tendent of the Ross Rifle Company, who is also on the Board of Directors. The contract is to be completed by December 31, 1919, and it is said that the maximum number of employees will reach 3.000.
