## WAR VETERANS AGREE TO STOP RIOTS

## MOB OF 5,000 ATTACKED BY CONSTABLES

Police Charge Crowd With Drawn Batons-Injured

Sent To Hospitals

## PROTEST MEETING IS HELD

TORONTO, Aug. 7 .- Accepting as an invitation the announcement of Mayor Church, made Tuesday night, that he would read the riot act from the steps of the city hall at noon today, about 10,000 men and women gathered to witness this event.

The mayor, however, did not take the drastic measures which he had threatened. The mayor stated that during the morning he had held a conference with a committee of the returned soldiers, who had agreed on behalf of their comrades, that there should be no more parading

pending an official investigation into the men's grievances.

The mayor also read a civic proclamation entreating the people of Toronto to observe law and order, and avoid unlawful assemblies. Should there be any more rioting, the proclamation said, the Riot Act would be read and the police and militia would have authority to fire on any mob.

Then followed a singing of the national anthem and cheers for the king, after which most of the crowd dispersed. Police Charge Crowd

Following another clash Tuesday evening between the police and a mob of 5,000 citizens and returned soldiers, Mayor Church announced that the Riot Act would be read in Toronto today.

After holding a meeting in Queen's Park and expressing indignation at the conduct of the police force which vigorously suppressed the rioting Saturday, the crowd started to march down town. It was dispersed by 40 policemen, who charged with drawn batons. A number of persons were injured, including four who were sent to hospitals.

The crowd gathered in Queen's Park in response to an invitation of a citizens' committee to consider the recent disturbances. Several resolutions, setting forth the policy which they demanded the government should follow in deal-
