ENEMY PROPERTY IN CANADA

Government Activities in Enforcing Regulations Reviewed

(Canadian Press Despatch.)
Ottawa, Dec. 13.—A statement has
been issued by the Government reviewing its activities in enforcing the various regulations respecting enemy property and enemy business dealings in Canada. It is pointed out that since the consolidated respecting trading with the enemy. respecting traing with the entray were passed, the department of the Secretary of State has made numerous investigations, inquiring into every case of aller enemy property or dealings which has been brought to its attention. In many instances chartered accountants have been engaged to investigate and submit reports, and among the list of firms gaged to investigate and suomit re-ports, and among the list of firms whose businesses were thus investigated are the different con.paries in which Alvo von Alvensleben of Van-couver was interested.

Debt Claims Dealt With.

In addition, the Finance Department has been engaged in carrying out the provisions of the orders, in collecting moneys, registering enemy properties in Canada and claims of the data by properties. properties in Canada and claims of debts due by persons in enemy countries to Canadiaus, and vice verse. These claims are now being dealt with by the Enemy Debts Conneil tee, and particulars of the claims are being forwarded to Canada's representatives at the Peace Conference. The statement continues:
"Information as to enemy properties and dealings have been obtained from many sources, censored letters.

from inquiries partment of the Secretary of State by individuals and from inquiries In many cases all difficutties are cleared up by correspondence, which proves the innocence of parties con-cerned, showing that it is anneces-sary to make an investigation. Where, however, enemy property in Canada is indicated, or debts owing to alien enemies by Canadians, or dealings contrary to the terms of the consolidated orders, investigations have been fully and completely made have been fully and completely made Where the correspondence dia no disclose the facts completely, the dia not cases have been placed in the hands of chartered accountants for inves-tigation, and detailed reports have been submitted.

Property Matters Referred to Courts.

Where these reports indicate enemy property in Canada, or nebts owing to alien enemies, applications have been made to the cours tor the appointment of receivers and controllers, or for the winding up of the enemy concern. The Secretary of Stare has authority under his own controllers, or for the summand the enemy concern. The Screetary of State has authority under his own warrant to wind up an enemy concern, but after due deliberation it was considered advisable that the authority of the court should so invoked in all cases. It is impossible to say what may result from the treaty of peace with respect to enemy property and debts, and it was treaty of peace with respect to en-emy property and debts, and it was considered proper, for the protection of all concerned, that the courts alone should deal with enemy property.
